What is the 'Immigrant Investor Scheme for Public Business'?

If you invest **1500million KRW** or more in public investment products of the Ministry of Justice, **you can obtain F-2 residential status** which gives you economic freedom, and you can acquire Permanent Residency if you successfully maintain the investment capital as well as **F-5 residential status** for the next 5 years.



Benefit of immigrant investor

The same benefits will be granted to not only an investor but also his/her spouse and unmarried children. Investors will be allowed to freely enter, depart, live, work, run their own businesses, and study in Korea.

Required documents for application F-2 VISA

- 1 PASSPORT ,PHOTO, FEE
- 2 Documents to prove the payment of investment (Receipt of deposit)
- 3 Documents to bring foreign currency
- 4 Family relation certificate etc.
- 5 Tuberculosis certificate
- 6 Criminal record certificate
